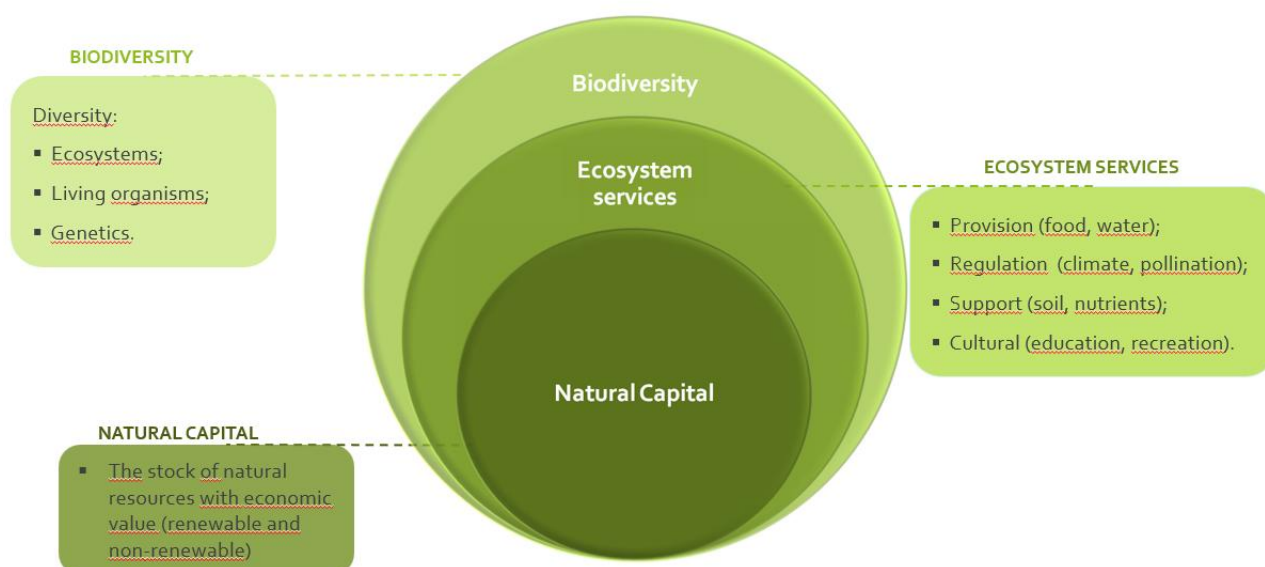
1. INTRODUCTION

The LIFE Methodology is a tool developed by the LIFE Institute to promote business engagement with biodiversity and ecosystem services.

2. DESCRIPTION

2.1 LIFE METHODOLOGY

The LIFE Methodology has a mixed, measurable, and integrated approach, giving it an innovative and tangible bias through its qualitative and quantitative structure focused on biodiversity management, as shown in the image below:



Composed of metrics and management indicators, it leads to an objective analysis of the positive and negative impacts on biodiversity, as well as the risks, dependencies, and opportunities in the relationship between business and biodiversity.

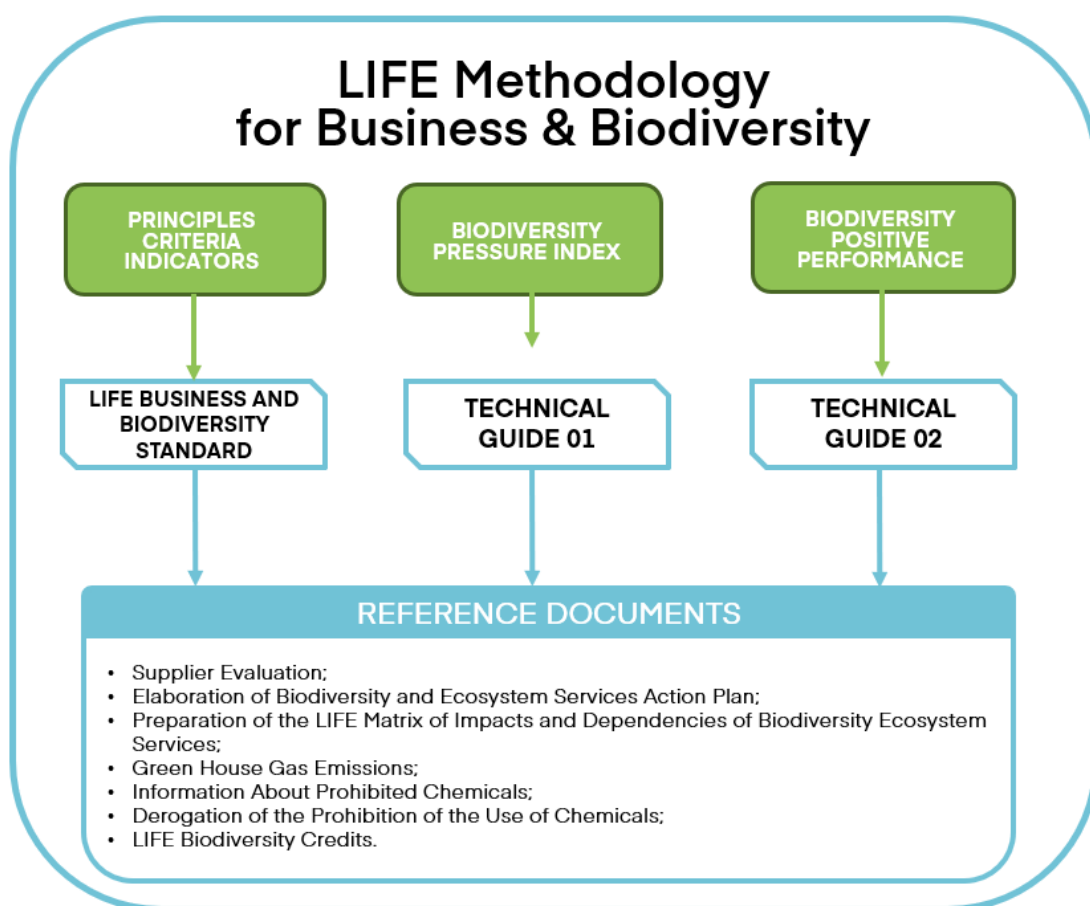

Incorporated into the LIFE Key software, its application enables the assessment and monitoring of organizations' performance in relation to biodiversity. In addition, the application of the LIFE Methodology allows the generation of LIFE Biodiversity Credits.

Further details on the applicability of each module of the LIFE Methodology, including the generation of Biodiversity Credits, can be found in the Audit Guide.

2.2 LIFE METHODOLOGY COMPONENTS

The LIFE Methodology consists of different modules, including qualitative indicators of organizational management and metrics that allow the calculation of positive and negative impacts on biodiversity.

2.3 LIFE METHODOLOGY FOR BUSINESS & BIODIVERSITY DOCUMENTS

Given the need to adapt the Methodology to different countries and regions the code assigned to each document might alter. Examples of that are the Technical Guides: “LIFE-BB-IN-TG01” stands for the Guide adapted to international applicability, while “LIFE-BB-EU-TG01” represents the Guide adapted to applicability within Europe. An example of this can be found in Table 3.
